As a result of your application for insurance, we have provided a quotation for Actual Cash Value (ACV)* property coverage under one of the following ACE Recreational Marine Insurance® products:

- ACE Departure Yacht® Policy
- ACE Departure CharterSM Policy

So you can more fully appreciate the benefits and scope of coverage offered in our quote to you, please read the following additional details and explanations of the policy that will be issued to you:

Actual Cash Value (ACV) – is defined in the policy as fair market value of the insured property at the time of loss.

Total Loss Settlement – if the insured vessel is completely lost or destroyed or the cost of recovering/repairing the insured vessel is more than the applicable coverage limit, payment by us for such a total loss shall be the ACV of the insured property up to the applicable coverage limit.

Partial Loss Settlement – if there is loss or damage to your vessel or property that does not result in a total loss, payments made by us for such partial losses shall be reduced by depreciation and the policy deductible will be applied.

Loss or Damage to Machinery – payments we made for the repair or replacement (including labor) of vessel machinery shall not exceed 25% of the applicable property damage limit.

Salvage – payments we make for salvage charges arising from a covered loss will be in addition to any other payments we make for losses covered by the policy. However, payment for salvage charges will be no greater than 25% of the applicable property damage. Also, the property damage deductible amount shall not apply to payments we make for salvage charges.

All of our other valuable features – Liability Protection, Medical Payments, Uninsured Boater Coverage, LHWCA, Personal Property & Fishing Equipment Coverage, Towing, Tender/Dinghy Coverage and Trailer Coverage are included in the Departure Yacht and Departure Charter Policies.
